### Sudden death of carrier CO



The commanding officer of the USS Harry S. Truman died

suddenly on 8 November 2011. Capt. Tushar "Haaji" R. Tembe, USN had taken command of the Truman just several months before his passing in August 2011. Previously Tembe was XO of USS Dwight D. Eisenhower and CO of USS Nashville and CO of Strike Fighter Squadron 87 and served as a fighter pilot Eisenhower and Forrestal attached to VFA-132. VFA-83. His service covered almost three decades. His funeral services were celebrated in The Holy Family Catholic Church in Virginia Beach, VA, at 2 p.m. Sunday, 13 November



The USS Harry S. Truman held a military memorial service on Tuesday, 15 November 2011, at 1 p.m. on board USS Dwight D. Eisenhower in Norfolk Naval Station, VA (photo above). A full military funeral will be held at Arlington National Cemetery at a future date.

# XO takes temporary command of CVN-75

Capt. Craig Clapperton, USN took interim command of USS Harry S. Truman CVN-75 on 9 November 2011 until a new commanding officer was named after the death of Capt. Tushar Tembe on 8 November 2011. Capt. Clapperton was relieved of command by the former CO of the USS Enterprise, another temporary command, by Capt. Dee Mewbourne. Mewbourne had been CO of USS Enterprise

from 2008 to 2010, when he was relieved by Capt. Owen Honors. USN. Honors made national headlines when it was revealed that he took part in raunchy video skits aboard the USS Enterprise while XO. When the videos went virile on the Internet. the Navy removed Honors from command. and Capt. temporary Mewbourne took command of Enterprise. He was relieved by Capt. William Hamilton on Enterprise August
